Because of you, doors opened that changed the trajectory of children's lives.

During the **fiscal year ending September 30, 2025**, more than **300 children** walked through the doors of **Butterfly Bridge CAC for the first time**—each one carrying a story no child should have to tell. Because of your support, they were met with compassion, expertise, and a coordinated response designed to bring clarity, protection, and healing. From that very first step, doors began to open: doors to safety, to answers, to justice, and to hope.

Through our work, children and families in Chilton, Autauga, and Elmore counties received critical services including **forensic interviews, trauma-focused therapy, family advocacy, and access to forensic medical exams**—each service carefully delivered to reduce trauma and support both healing and strong investigative outcomes. Behind every number is a child who was believed, a family who was supported, and a path forward that became possible.

This past fiscal year was marked by both growth and challenge. As the need for services continues to rise across our communities, so does our commitment to meet that need with excellence. At the same time, uncertainty in some of our funding sources reminds us just how essential our **local communities** are to this work. It is the generosity, advocacy, and engagement of those closest to home that ensure these doors remain open—today and for years to come.

But as we reflect, we also look ahead.

The path forward calls us to do even more—to open wider doors, to reach more children sooner, and to ensure that every child who needs us has access to the care they deserve. Together, we are building a future where every child has the opportunity not just to heal, but to thrive.

ROOMS OF HOPE

Through a meaningful partnership between Cherie, Rooms of Hope Volunteer Coordinator, and Butterfly Bridge Children's Advocacy Center, the Rooms of Hope program is helping child victims reclaim a sense of comfort, peace, and safety in their own homes.

For many children who have experienced abuse, their bedroom can become a painful reminder of trauma. Rooms of Hope works to transform those spaces into places of healing by redecorating and refreshing bedrooms for children and teens served through BBCAC.

What may seem like new paint, bedding, décor, or furniture can represent something much deeper — hope, restoration, and the opportunity to move forward.

Cherie shared the personal experience that inspired her commitment to this mission:



"I am so passionate about this project because I was a victim myself at 12 years old. The abuse happened in my own bedroom. It has been almost 40 years ago and I still remember and can visually see the furniture that was in my room. It was a constant reminder every time I went in there.

It wasn't until a year later that my family redecorated my room. I can remember how much easier it was to go in there when it at least looked different. It allowed me to not have that constant reminder.

I feel the purpose is to allow victims to get some relief. They will probably always remember what happened to them, but at least a new space gives them a chance to move forward. I feel it's hard to move forward when you are continually in the same space. Rooms of Hope offers that possibility. I am thankful for my daughter,

Abbey and husband Kevin for helping complete Rooms of Hope projects."

The impact of this program reaches far beyond the room itself. Families have expressed overwhelming gratitude for the opportunity to create a mentally safer environment for their child without the added financial burden during an already difficult season.

Because of Rooms of Hope, countless children have been given more than a redesigned bedroom — they have been given comfort, dignity, hope, and a fresh start on their healing journey.

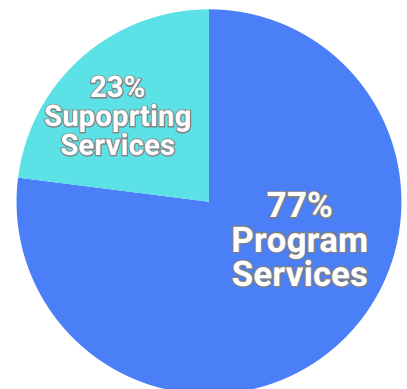
